	Construction of compound wall in property bearing sq. no. 61/1 of Bomburpa village					<p>Knitika Latha towards Shrawane area bearing no. VR/PO/2026-27/65 & VR/PO/2026-27/64 respectively is placed in the panchayat body meeting for decision. The reply submitted by the party, along with annexures and records is perused by the panchayat body. The panchayat also considered the site inspection reports, revenue complaints and proceedings conducted in the year 2023. Upon examination, the panchayat body observed that the wall in question is claimed to be a pre-existing gada wall, previous complaints on the same issue were examined by the Panchayat in 2023 wherein no illegality was established with respect to the said wall, no direction was issued earlier for demolition of the said wall & the panchayat had subsequently issued an occupying certificate dt. 20/08/2025, indicating that the construction was material. In view of the above and the material placed on record, the panchayat is satisfied that no concrete evidence of unauthorised construction of a new wall is established.
